RySS is the implementing authority for the Andhra Pradesh Community Managed Natural Farming (APCNF) program, aimed at fostering climate-resilient, sustainable and nutrition-sensitive agricultural systems. PHFIIPHS and RySS are currently collaborating with the objectives of improving the health and nutrition status of farmer community in APCNF areas, strengthening community-based health and nutrition counselling in APCNF areas and integrating scientific research and evaluation approaches into field programs for policy advocacy and scalability.
